a) CET CELL will display Provisional Merit List as per the Schedule displayed on the concerned CAP web site.

i) Candidates who have filled in their CAP Application Form and filled in the Option form and approved both the forms from their log in, their names will appear in the Provisional Merit List.

ii) Candidates who have registered themselves for the CAP process but have not approved their Application form and or Option Form, their names will appear in the separate list. Such Candidates will not be included in the Final Merit List and will be eligible for CAP Round III and IV if they complete their Application form and or Option form and approve both from their log in as per the schedule before the start of the Third round.

But their names will appear in the New Merit list for Third Round and they will be considered for allocation after considering the Candidates of Final Merit list.

b) Submission of Grievances after display of Provisional Merit List:-

i) After the Display of the Provisional Merit List, the candidates will be able to submit on line Grievances as per the schedule given in column no 4 in the above Table.

ii) During the Grievance Period the Candidate will be able to unapprove the CAP Application form and Edit the same. The candidate can edit his Name, Date of Birth, Caste/Category, Candidature Type, Marks of the Qualifying Examination etc., if they want to correct these details. Candidates should remember to approve the CAP Application form without fail. Otherwise his name will not appear in the Final Merit List and they will be responsible for the same.

iii) During the Grievance Period the Candidates will be able to remove the in-correct documents uploaded and scan and upload the correct documents and submit the CAP Application Form.

iv) In No Case the Candidate will be allowed to Edit his Option Form during Grievance Period.

v) Since the Final Merit list is going to be prepared on the basis of the information filled in by the candidate, utmost care is to be exercised by the candidate to fill in the correct details and upload the correct documents. If the admission of the candidate is not confirmed at the college level due to incorrect information and or uploading of the wrong document, the candidate himself will be responsible for the same.

c) i) CGPA to Grade Conversion:- ii) which marks to fill in iii) Which Marks Memo/Mark List to upload.

CET CELL has received queries about above questions, though they have been explained in detail in the Information Brochure of every course.

i) CGPA to Grade Conversion:- Where the Board / University awards Certificate/ Diploma/Degree on the basis of GPA/CGPA/Grade, the candidate has to seek conversion formula from the University/Board Institute upload the same on the letter head of the University/Board/Institute or in the self- attested format on the plain paper.

ii) Candidates have sought clarification of which marks to be entered. We have stated that the marks considered by the University/Board/Institute for award of Degree/Certificate/Diploma are the marks to be entered by the candidate.

iii) Candidate needs to upload that marks memo/list on which the Final/ Total Aggregate marks are recorded along with conversion formula mentioned in C (i) above.

d) Cut of Dates for uploading Caste Validity and or Non-creamy Layer Certificate/s
Maharashtra State candidates belonging to Categories are required to
submit/upload Non Creamy layer and Caste validity Certificate on the admission portal
before the last date of admission of the Second Round of Allocation as per the schedule.
This facility will be available for the Candidates who have uploaded Caste Validity Receipt
and or Non- Creamy Layer Receipt. The current dates declared by the CET CELL as per
