Read:- 1) Government Notification Extra ordinary Gazette No 113 dated 5th May 2017

CET CELL has received requests from Candidates and Colleges that candidates have committed mistakes in i) Candidature Type, ii) Category iii) Uploading of Documents iv) Entry of wrong Marks v) Uploading in correct Document, Some Colleges have admitted candidates who have filled in incorrect details and or uploaded in correct documents, wrong method without verifying the details at admission level.

In view of the same CET CELL is providing last opportunity to the CET qualified candidates whose names appeared in the first Merit list dated 24th August 2018 and 3rd Round Merit List dated 29thSeptember 2018 to edit their Application Form (Part I) and correct their credentials on line and upload the corrected documents before the start of the Fourth Institute Level Round.

Candidates whose Application form were incomplete and hence their names were not included in Merit list I and II will also be able to edit their already filled incomplete application forms and upload the correct documents as per the schedule given below

The candidates who want to participate in the Fourth Institutional Level Round will not be required to Edit or Fill Part II (Option Form).**No. Candidate can register as new candidate during the Process.**

The Provisions in the Government Notification Extra ordinary Gazette No.113 dated 5th May 2017 related to filling in various seats in the Institutes are being reproduced for the benefit of the Institutes and Candidates as under:-

- Filling in of vacant NRI/OCI/PIO/seats in Unaided and Unaided Minority Colleges:
Read and Refer to 7. Allocation of Seats: (4) (ii) and (iii) Page No 49 and 50.
- Filling in Minority Quota Seats in Minority Institutions:
Read and Refer to 10. Cap Allotment Stages and Process of Allotment (3) Page 52-53.
- Admissions in Institutional Quota and Filling in Vacant Seats after CAP Round 3:
Read and Refer to: (13) (a) to (h) page no 55-56.
- There is no Management Quota in any College of Education as per Directives of NCTE and Department of Higher Education.
- The candidate who have not appeared for ELCT Examination will not be considered for Admission to English Medium Colleges.**

f) Logic for Change of Category:

- Group 1:** i) Scheduled Castes and Scheduled Castes converted to Buddhism (SC)
ii) Scheduled Tribes including those living outside the specified areas (ST)
Group 2: i) Vimukta Jati (VJ) / Denotified Tribes (DT) NT(A)
ii) Nomadic Tribes (NT-1) NT(B)
Group 3: i) Nomadic Tribes 2 (NT-2) NT(C)
ii) Nomadic Tribes 3 (NT-3) NT(D)
iii) Other Backward Class (OBC)

2. After following the stage IV (i) if some seats still remain vacant then those will be filled on the basis of a consolidated merit list of all remaining backward class candidates.

3.(a) After following the state Stage IV(ii) if some seats reserved for backward class remain vacant, they will be filled from the merit list of open category candidates.

Logic for Change of Subject/ Method.(Only for B.Ed.)

.I) If the seats of particular subject remain vacant, those will be filled in by making changes as shown below by the Centralized Admission Committee. (Only for B.Ed.)

II)If seats remain vacant from the reservation of women in particular subjects/category then vacant seats will be merged in General Merit List of the same category and subject seats will be filled in.

g) Logic for Change of Subject/ Method seat:---

i) Interchange within **Language Group**.

ii)Interchange within **Science and Agriculture/ Medical** .

iii)Interchange between **Information Technology, Engineering and Mathematics**

iv)Internal change between **Science and Mathematics**.

v)If the seats remain vacant after executing above interchanges of **Languages, Science, Mathematics and Commerce**, then those seats will be distributed to **History Geography, Social Science** as per the quota allotted to these subjects.

vi)Inter changes between History and Geography after interchanging, if some Seats remain vacant, they will be allotted to Social Science

vii)If some seats remain vacant, a consolidated merit list of all the subjects will be prepared and then seats will be filled on the basis of combined merit of all subjects.

The colleges and Institutes will follow the provisions in the Information Brochure and the Government Notification cited under reference for filling in the vacant seats after CAP Round 3.

Procedure about Admitting Candidate in Round IV: Institutional Round:

a) The Colleges will generate the Candidature Type wise Merit list using the facility on admission portal :<http://bed.mhpravesh.in>. The same merit list should be displayed on the College Notice Board and College Web Site.

b) The Colleges will download the Provisional Admission Letter by filling the relevant admission details of the seat and the candidate and verify the credentials of the candidate and confirm the admission from the college log in before the due date/cut off date.

c) The Fourth Institute Level round is being conducted at the level of the College and as per the Provisions in the Government Notification cited under reference. It will be responsibility of the Heads of the Institute to fill in the vacant seats as per the Schedule given and provisions contained in the Information Brochure and Government Notifications. In No case Merit is to be violated. **Every wrong admission in any round will be penalised.**

Instructions about Caste Validity and Non-Creamy Layer:

All MS Candidates belonging to the Reservation Category must have the Caste Validity and Non-Creamy Layer (Excluding SC and ST) Candidates. Without which they will not be considered for allocation under Category Quota. Any candidate admitted in the earlier round who has not submitted Caste Validity before the cut- off date of submission of Caste validity 18/9/2018 should be admitted through open category in Institutional round as per merit if Caste Validity and valid Non Creamy Layer Certificate is not available.

The Colleges will maintain the logs of the application forms received by the College, Merit list generated and admissions confirmed in ACAP seats. Institute must give acknowledgement of the Offline application form submitted by candidate with date and Time and Signature of the College Representative.

The Schedule dated 10/8/2018 will be updated accordingly.
