

Important Instructions to Colleges and Candidates for LL.B-3 Yrs. For Round IV INSTITUTIONAL LEVEL ROUND about Vacancies and Facility for Editing the Application form.

1) **Clarification about the Seat position displayed on the admission portal:- PH/Ex-Active Service man and Orphan reservation is Internal-Horizontal Reservation. The Vacancy position displayed on the admission portal includes the seats meant for the Candidates.**

2) **Important Instructions to the Already Admitted Candidates Editing their LL.B-3 Yrs. Application Form Round 4- Institutional Level Round.**

- 1) If the Already Admitted Candidates desires to edit their CAP Application form for Institutional Level Round, then Candidates has to cancel the earlier admission from admitted college.
- 2) Candidate has to submit duly-signed written application for cancellation of admission to Admitted College.
- 3) **College will verify the application and then cancel the admission of candidate from college login. Once admission is cancelled cannot be restored again in the earlier round.**
- 4) After cancellation of admission by the Admitting College, candidate will able to edit his/her own application form, from candidate's own login.
- 5) Cancellation of Admission Link will be activated from **22 October 2018 to 23 October 2018**. Colleges who have admitted wrong candidates in the earlier round may at their own discretion cancel the admissions of the candidates and consider them for Round IV as per the Merit. **The system will automatically update vacancies of the College after cancellation.**
- 6) ARA and DHE will not accept any wrong admission except in cases where in Hon High Court has given a special relief to a particular candidate, in such cases the college/ Candidate has to upload the certified copy of the Judgement on the admission portal and the admission letter of the candidate should specifically mention the special Remark with mention of the Writ petition.
- 7) During the Cancellation and Editing link the candidates who have not been able to obtain Caste Validity and or Non Creamy layer Certificate can change their Category and make payment on line for remaining balance fee.
- 8) Candidates who have not uploaded CET Examination Hall Ticket or NC from the Police Station, CET Application Form can do so after cancelling the Admission if already admitted and editing the application form and uploading the required document.
- 9) Candidates are intimated that this is the last opportunity being offered to them set their credentials correct.
- 10) If the Candidates/Colleges do not act as per the instructions of the Notice, they themselves will be responsible for the consequences.
