Conduct of Round III for M.P.Ed. 2018-2019

A) Conduct of CAP Round-III. —

- (a) The seats available for The Last Online Centralized Admission Round shall be published on the website <http://mped.mhpravesh.in> on or before 18th September 2018.
- (b) Candidates who have not been allotted any seat in any of the previous rounds (Round I & II) or who did not participate (failed to fill in option form) in previous round or those who have taken and cancelled their admission in the earlier rounds or rejected admissions are eligible to participate in this Round III Final Round of On Line Allocation;
- (c) The Candidates are allowed to Fill in or Edit the already filled Online Option Form from 18th September 2018 6.00P.M. onwards to 24th September 2018 11.59 Midnight.
- (d) The Candidates who do not change their (Application form Part- I) Personal Information and/or Academic Information and edit only Option form, their Merit No of the First Merit List for First and Second Round will be maintained in the Third Round.
- (e) Candidates should remember that this is the Last and Final Round of Online Centralized Admission Process conducted by CET CELL/DHE.
- (f) Hence, Candidates should be Extra careful about Editing the Option Form.
- (g) Float options are not available for the seats allotted in this Third and Final On-Line Centralized Admission Round.
- (h) To participate in the Last online CAP Third Round of Admission, it is mandatory, for all the candidates to Fill and Complete / Approve the Option Form.
- i) All the Candidates who have confirmed their admission in the First and Second Round, System will NULL the Option form data, if they are desirous of seeking admission in new college of their new choice they have to fill and complete the Option Form & Approve for Third Round. If the Status of the Option Form of the Candidate is Incomplete for Third round, such candidates will not be considered for Third Round of Allocation by the System. Hence the Candidates are advised to carefully Fill, Complete and Approve the Option Form.

j) Candidates who have confirmed admission and also applying for this third round shall not fill in the allotted institution in their choice list. It will be added by the software at the end of the list. Once the upward allotment is made, the earlier allotment automatically stands cancelled due to **Dynamic Allocation**, hence the candidates should give their options for Round III judiciously and carefully.

(k) Candidates who have not been allocated seat in any of the previous rounds and whose CAP and Options forms are complete and approved may choose to edit their option form. If they do not edit their option form their existing options will be considered for the Third round.

(l) Those candidates who have confirmed their admission in the First and Second Round and have confirmed their admission in the admitting College by Paying Stipulated fees of the admitting college, will be eligible to participate for the Third Round as per the provision given in admission rule 9 (3) (ii) Govt. Gazette, Extraordinary, Part-IV-B, Extraordinary No. 113, Dated 5th May 2017.

(m) Cancellation of Admission of the candidate, who has confirmed his admission in the First round or Second Round on written request of the candidate, will be executed by the Principal as per the Schedule when the admission link is open for the Third Round. Principal pay back the fees to the candidate by deducting 1,000/- as Administrative Charges. It is the responsibility of the Principal to provide the online Acknowledgment of Cancellation of Admission to the candidate. After receiving the on line Acknowledgment of Cancellation of Admission candidate should submit this receipt to the newly allotted college in round III, then only college will confirm the admission of the candidate allotted in Round-III. Cancellation of earlier Admission and seeking admission and registering the Admission on the online portal are the joint responsibility of the candidate concerned and the College concerned.

(n) The Institutes will verify the documents of the candidates who have exercised the Freeze Option and if there is no discrepancy, the college will confirm the admission of the candidate and accept the fees and give the official receipt to the candidate and upload the status of admission on the Admission Portal. Reporting and Accepting the offered seat will as per the allotment by the Candidate at the Admitted College.

(o) The candidates whose names have appeared in the First Merit List declared for First and Second Round, chooses to change Personal and Academic information by clicking on "I Want To Edit Application Form" button with or without change to Option Form will be eligible for III round but their merit ranking will be considered at the end of the Final Merit list. These candidates will be considered for allocation after the candidates is played in the Final (First Merit list for Round I & II) Merit list.

(p) Candidates who newly registered in the CAP round for the first time, are eligible in this III round. NOTE: All the newly registered candidates will be added at the end of the Final Merit list

i.e. after the Final Merit list and after the edited merit list of the existing registered candidates as mentioned in above. These candidates will be considered for allocation after the candidates displayed in the Final Merit list and after the candidates who have been added to merit list based on their edited personal or academic information.

(q) All newly applied candidates should take care to fill in the details correctly and upload the correct documents; otherwise, Candidates will not be able to participate in the Third and Final On-Line Round of Admission.

(r) Already admitted Candidates of Round-I and Round-II who could not upload the Caste Validity Certificate and or Non Creamy Layer Certificate during the prescribed period 15th September 2018, their admissions are to be cancelled by the admitting college. If the College/Department fails to cancel the admission of the candidate not submitting and uploading Caste validity/Non-Creamy Layer certificate within the cut off date, the College /Department will be responsible for the same.

The candidates can upload the caste validity and Non Creamy layer certificate during 18th September to 24th September 2018 and can be Eligible for allotment in the Third Round.

(s) Already admitted candidates of Round-I and Round-II who choose to edit their Personal and/or Academic details by clicking on "I Want To Edit Application Form" button in the Application form, should carefully note that their admissions in Round I/II will automatically get cancelled and their name will be considered in the New Round III Merit List and will be considered for allocation after considering the candidates of the Final

Merit List published for the First and Second Round, subject to their completion and approval of the CAP Application Form.

(t) **Fourth Round** of Admission is going to be conducted at the Institute Level. The Institutes will be filling in the A-CAP seats as per the Merit. Seats will be filled in as per respective merit by generating merit lists through admission portal. There is no Management/Institutional level Quota as per NCTE Directives.
