Postponement of mop up round of counselling for admission to MBBS/BDS to be held on 29.08.2017.

Please refer to the subject cited above.

- 2. I have been directed to convey to you that in view of law and order situation arising due to conviction of Chief of Dera Sachcha Sauda, Sirsa on 25.08.2017 by the CBI court, Panchkula and subsequent events and finally his sentencing by the CBI court in Rohtak on 28.08.2017, the bus and train services to and from Haryana have been disrupted. In fact, a huge crowd had started gathering in Panchkula in anticipation of conviction of Dera Chief in Panchkula from 23.08.2017 itself, as a result there was fear psychosis in the minds of general public and therefore, mop up round earlier scheduled for 27<sup>th</sup> & 28<sup>th</sup> August, 2017 had to be postponed to 29.08.2017. The situation has not yet returned to normalcy and the focus has now shifted to Rohtak town because of shifting of Dera Chief after his conviction to Sunariya District Jail, Rohtak. The CBI court was also held in the Jail premises in Rohtak on 28.08.2017, where the Dera Chief has been sentenced to undergo rigorous imprisonment of 10 years. The bus and train services to and from Haryana have still not resumed.
- 3. Keeping in view the above unprecedented situation, the mop up round for admission against vacant seats scheduled for 29.08.2017 is hereby postponed. Now this will be held on 30<sup>th</sup> August, 2017. The following notice may be put up on the website of the University and Admission web portal for information of all candidates;-

"It is for the information of all candidates desirous of participating in mop up round of counselling for admission to MBBS/BDS courses in Government, Government aided, private Medical/Dental Colleges including those under SGT University, Budhera, Gurugram (Private University) in mop up round against left over seats that due to current law and order situation arising on account of conviction of Chief of Dera Sachcha Sauda, Sirsa on 25.08.2017 and his subsequent sentencing on 28.08.2017 by the CBI court, the bus and train services to and from Haryana have been disrupted. Therefore, the counselling scheduled for 29.08.2017 has been postponed to 30.08.2017. The candidates who will be successful in securing admission to MBBS/BDS on 30.08.2017 shall have to deposit the full fee on the spot to confirm their admission. They must bring with

them the original requisite documents and bank/demand draft of requisite amount i.e. Rs.10 lakh or Rs.18 lakh for MBBS (for Adesh Medical College or for SGT Medical College, as the case may be) and Rs.2.80 lakh or Rs.3.50 lakh for BDS (for Dental Colleges under Pt. B.D. Sharma University of Health Sciences, Rohtak or SGT Dental College, Budhera, as the case may be). The demand/bank draft should be in the name of 'Registrar, Pt. BD Sharma University of Health Sciences, Rohtak' payable at Rohtak. In case of non-deposition of fee on the spot, will be allocated to the next candidate in the merit'.
